Dear Participants,





David Restrepo Amariles is a professor at HEC Paris and ULB, as well as a researcher at the Perelman Center for Legal Philosophy of ULB and a visiting professor at Sciences Po Paris.

He uses quantitative and socio-legal research methods to study new instruments for regulating transnational trade, commerce and investment.

He is also a member of the Colombian Bar Association.



Prof. Mireille Hildebrandt

Mireille Hildebrandt is a lawyer and a philosopher working at the intersection of law and computer science. She is a Research Professor specialised on 'Interfacing Law and Technology' at the Vrije Universiteit Brussel and holds the Chair of Smart Environments, Data Protection and the Rule of Law at the Institute for Computing and Information Sciences (iCIS) at Radboud University Nijmegen.

She has published four scientific monographs, 21 edited volumes or special issues, and over 100 chapters and articles in scientific journals.

Ambassador of France to Uzbekistan, Isabelle Servoz-Galluci is a lawyer by training, specializing in public international law and international relations.

In 2003, she joined the Council of Europe where she successively worked in the Directorate of External Relations, the Directorate of Political Affairs and Democracy, the European Committee for the Prevention of Torture and Inhuman or Degrading Treatment or Punishment, and the Office of the Directorate General of Programs.


